Forums User Guide – External

Forums are a new feature built within California's Department of Public Health (CDPH) Technical Assistance Inquiry and Grant Management Equity Portal **(Equity Portal)**, designed to be used as a tool to enhance peer to peer communication and knowledge sharing, among Local Health Jurisdictions (LHJs) and community partners. Each Forum will have a Moderator assigned from the Office of Health Equity (OHE), and that Moderator will be responsible for <u>adding and removing participants</u>, protecting privacy of individuals and upholding the Forum code of conduct, as well as generally maintaining a safe space for discussion and the sharing of resources.

As a Forums Participant, access the Forums from the Equity Portal

- 1. Navigate to the Equity Portal and sign-in, using your existing username and password
 - a. If you do not have an existing username or password and have never signed into the Equity Portal before, please email <u>EquityPortalSupport@cdph.ca.gov</u> with your request for an invitation to register

Reporting Violations

Note: Any Post or Thread that includes any of the prohibited content below will be either edited or hidden by the Forum Moderator to remove or hide offensive or private information that is in your Post. The Post will be reviewed by the Office of Health Equity (OHE) legal team to assess if it should remain public or not on the Forum. Individuals who consistently post prohibited content might be removed from the Forums, pending a review from legal.

- Defamatory, as defined as, false or misleading information and harmful words intended to damage the reputation of another person(s)
- Indecent, as defined as, the inclusion of obscene language, foul language and/or pornographic material

- Which participants will be added to this Forum (ex: LHJ Equity leads, list of specific external community partners, attendees of a particular meeting series

The Equity Portal Team, along with relevant members of the Office of Health Equity will regularly review these requests and make decision regarding the creation of new Forums. You will be notified if you request has been approved or not.

Remember, Forums are for peer connection and conversation! If you have questions for the internal Office of Health Equity team or your TA specialists, you are welcome to submit an <u>TA Inquiry</u>.
